Applications for Branch Change in B.Tech – 3rd Sem. (2025-26)

All Students of B.Tech – 3rd Sem

In reference to the University Circular vide ref. no. AKTU/CoEO/2025/Branch Change/2286 dtd. 10/11/2025, this is to inform to the students of B.Tech – 3rd Sem that if any student wants to change his/her branch, he/she may apply for the same through prescribed form (as attached) along-with required documents **latest by 17/11/2025 (Monday)** at Window-1 in Office.

Prime Criteria as follows but not limited to -

- Student passed with minimum 6.5 YGPA or higher marks in the First Year without Carryover Paper and has passed all the subjects in single attempt, shall be eligible for branch change.
- Re-admitted/Ex./ Lateral Entry students shall not be eligible for branch change.
- If a student has applied for Re-evaluation/scrutiny of 1st and/or 2nd Sem. result and result has not been declared yet, then such student shall not be entitled for change of branch on the basis of subsequently revised result.
- Fee waiver category student shall be eligible for branch change only against the approved intake of a fee waiver in a particular branch.
- Students taken admission under Gen-EWS category shall be eligible for branch change only against the approved intake of Gen-EWS category in a particular branch.
- The branch change will be strictly on the basis of merit and availability of seat.

Note:

1. Students are advised to go through the University Rules/guidelines, available at university website under circular tab, before applying for branch change.
2. After due date, NO application in any circumstances, will be entertained.
